General Rules/Guidelines

The tennis coach must be a current member of ICGSA to nominate a player. Coach's membership may accompany nomination form. Include membership payment with coach's form. www.icgsa.org

All information must be typed or printed neatly, or it will not be accepted. Information will be placed in the All-Star program and sent to area newspapers. The All-Star Cup will take place on June 9, 2024, at the Community Sports and Wellness Center in Pendleton, In.

Senior All-Star players will play a modified format of tennis during the event. Three rounds of tennis will be played by all players consisting of singles and/or doubles and a tie breaker set to showcase all players. Coaches of the tennis cup will be the ICGSA District Coach of the Year tennis coaches throughout Indiana. Only the designated high school tennis coach may nominate Senior varsity players. Only Information from the high school season will be used. Information about wins and losses against other 2024 nominees is vitally important to proper selection. Coaches and players will be notified by May 20, 2024, for selection to All-Star team.

Coaches are required to provide a complete listing, typed, or printed neatly, of the nominee's 2024 tennis season results. Position played, opponent, school, date, and score for each match should be included. Tournament updates will be added by the tennis committee.

ALL NOMINATIONS MUST BE RECEIVED NO LATER THAN May 13, 2024, Email to flem1.bf@gmail.com.

If you nominate more than one player, duplicate this form. The tennis committee will e-mail you and your player directly if selected to the team. If no player contact information is provided, then the school and/or tennis coach will be contacted to help inform the player of the recognition and deadlines.

Nominations are for SENIOR varsity players only, singles and/or doubles. This is a senior honor.
